2. State and National Activities

- a. Part C Update
 - State office supporting at local level systems around pandemic including telehealth, transition to face-to-face, and community settings.
 - Infrastructure work group looking at how EI is structured within 40 systems (billing, staffing, etc.). The goal is to look at the resources and ways to improve efficiency. Participants in work group are going back to their locality to gather more information to bring back to the work group.
 - Working with DMAS to continue telehealth post-pandemic. At this time, it is extended through end of June/early July.
 - VICC meetings are continuing to meet virtually. The public can still participate.

 - ECHO Autism Groups -
 - ECHO stands for ECHO: Extension of Community ECHO stands for Extension of Community Healthcare Outcomes - it originates through the University of New Mexico, <u>https://hsc.unm.edu/echo/get-involved/#start</u>
 - Two groups (UVA for practitioners and VCU for LSMs)
 - Dana has been providing training and support for teachers collaborating with families to support student learning. It has been very well received.

3. Members Ideas and Input

- a. ToT Topics
 - How people can access stuff now to get the professional development training hours needed
 - Hearing loss (updated ones including Telehealth or wearing masks in the home)
 - Terri Nelligan is a great point of contact. There is a lot going on at state level including mentors that could be included into the topic discussing what is in the works.
 - "Irene Schmalz is my go to for hearing loss she's part of the Partnership"
 - Kristin Karmon is a great SLP that works with Aveanna and specializes with children with hearing loss
 - Vision How have vision services looked during telehealth because services tended to be more direct in the past. It has been more difficult over the past year.
 - Tracy Deluca at the state department (Partnership) is great for vision
 - Working with families where English is a second language via telehealth
 - Not ToT specific- but a handout on resources or ideas for things available (Dana will follow up with Ana to get more ideas)
- b. SC Chat Topics
 - How to complete work in the world of telehealth
 - SC chat related to accessing interpreting services through the MCOs. This has been a struggle in the field and wonder if having a rep from MCOs or DMAS folks share how to go about this as the need is increasing with telehealth.
 - Kyla This has continued to remain a challenge. They are aware of the issues and still

working on resolving them. There is a process list to follow right now, but check on it next mid-year to see if people continue to struggle. They are also going to try to add the interpreter contact information.

- c. CSPD (Comprehensive System of Personnel Development) Update Content
 - Looking at updating and giving a new look. Specifically we want to consider:
 - Are people reading the Update?
 - What do they find most useful?
 - Is there anything NOT needed?
 - o Currently we tie the Update with the Talks on Tuesday topic. Like or dislike?

4. Resource Sharing

- a. Knowledge and Skills for Service Coordinators (KSSC)
 - New national resource broken down into six topics for the Knowledge and Skills for Service Coordinators (Infant and Toddler Development, Family-Centered Practices, Leadership/Teaming, Coordination of Services, Transition, Professionalism)

b. Functional Assessment Learning Path

- New Learning Path broken into five different pathways centered around the definition of Functional Assessment
- Feedback: The Google Drive links are hard to access. Staff tries to access on their phone and then the .pdf has trouble loading on their phones.
 - Our team is working on converting all the documents to a .pdf on our website to reduce issues. We will make the Functional Assessment Learning Path a priority.

c. Short Courses

 - New Short Courses (6 week consecutively)
 - Family-centered Practices and Natural Environments and Cultural Awareness, Routines-based El and Natural Learning Opportunities, Functional Assessment (Active Listening), IFSP Development, Service Delivery (Adult learning, coaching, & NLEPs), Teaming (working with SC, collaboration with other team members)
 - Experienced Short Courses (4 week consecutively)
 - Course topics: Functional Assessment, IFSP Development, Caregiver Engagement, Routines-based Intervention, Bias, Sharing your Expertise
