PD team then held 2/3 (3rd one will occur 4/24/19) of interviews with stakeholders that have an interest in functional assessment to gain input to determine strengths, challenges, and understanding of functional assessment. PD team will develop series based on results.
- Kaleidoscope-April 30, 2019 in Glen Allen
 - Currently, filled to capacity. 34 people registered. We like to keep smaller numbers for Community of Practice groups. Next Kaleidoscope will be in September in Valley region.

- Talks on Tuesdays-Cori/All
 - Apr/May-We Are All in This Together: Sharing Difficult Information with Families in El
 - Leah Davidson presented on Part I in April and archive can be found at <u>https://veipd.org/main/sub_2019_talks_tuesdays.html</u>. Part II will focus on a panel type discussion with multiple perspectives discussing sharing difficult information throughout different EI processes.
 - June-Medical aspects/updates re: autism
 - Dr. John Harrington from CHKD in Norfolk, well-known for work in autism, father of son with autism. He will provide update on medical information and how brains look different in autism.
 - Sept/Oct-ECMH/IMH ideas
 - Ana attended a training by a Fairfax social worker (Naomi Grimey) on social-emotional development. Ana will see if she can send presentation to Cori to see if it is appropriate. Ana shared this training received great feedback from different providers learning about themselves and dealing with families.
- o LSM meeting-3/26/19- Deana
 - Various topics covered throughout LSM meeting. There was a focus on supporting and taking care of themselves. - People excited about local program meetings and hosting meetings in various ways with SCs and providers which has been nice seeing how different roles discuss coaching practices.
- Launch late Jan/Feb next year
- Growing the Brain trainings Lisa
 - Zero to Three developed a new curriculum on Growing the Brain. Lisa has been piloting trainings for three localities with over 75 providers, service coordinators, LSMs, and community partners. Feedback indicates the training supports work with families by sharing information and teaching concepts about relating better with all families including being more empathetic to them.
 - Two more trainings coming up in Alexandria, VA in April and June.
- MEISR-Arlington work –Lisa
 - Arlington staff have been trained on the MEISR and receiving ongoing support. Materials will be developed as they are available for other agencies. The <u>child outcomes booklet</u> has a link to the MEISR.
- o Adult Learning Course-Dana
 - Completed recent course. There will be a follow-up meeting with that cohort in early May (two months after last meeting) to touch base. Dana will offer a quick review of what was discussed and problem solve with the group since the last meeting.
 - The format requires a lot of analyzing and feedback requiring limited number of participants.
 - There has been very positive feedback. Dana will try to continue to support the interest by offering one more time this year. Information to come.
