2. State and National Activities

- a. Part C Update Kyla
 - i. Working on addressing personnel shortages that are being experienced in some areas of state more than others. LSMs got together at the September LSM meeting to help brainstorm fiscal and personnel challenges. A lot had to do with connections in colleges and universities and how to infuse more about early intervention into courses and supporting professors teaching students. More will come as we continue to address issues like tips to share information with universities and how to host student interns.
 - 1. Christan has a birth to three course and a lot of students that are teachers expressed interested in learning more about early intervention. Lisa Terry came to talk to the students to host a live question and answer that was very beneficial.
 - ii. Office of Special Education Programs has given a lot of positive feedback on our SSIP plans. All the hard work is being recognized at the federal level.
- b. Institute of Higher Ed (IHE) Faculty Institute
 - i. Mira attended and reported it was helpful to learn more about other initiatives going on in the state. Small groups activities supported initiatives to collectively think about how to connect some of the policies at the state level to what is happening in the field.
 - ii. Christan attended and enjoyed the discussion on how embedding the information more intentionally and learning about resources like the learning bytes. They are great resources to use when teaching.

 - i. Service Coordination CoP Dana
 - 1. DEC has a service coordination of practice. Dana co-facilitates it with someone in Iowa who provides early intervention professional development. Anyone can join and does not have to be a part of DEC. Dana will be presenting on SC and Coaching for an upcoming webinar for DEC. It will be recorded and archived.

 - a. Adapt a Classroom project is live; Diana Smith, current VP/President elect is taking the lead on this.
 - b. PD Committee is still active. Cori Hill, Erin Croyle and Patty Eitemiller have a webinar in development focusing on a few of the RP's that highlight inclusion. It is tentatively scheduled for November, but may be pushed back as we are looking for a free/low cost platform to host the webinars without being reliant on other agencies, groups. Alison King, the current PD chair will be resigning effective January. She changed jobs from VCU to Longwood and was promoted shortly thereafter and needs to shift some things off her plate. Patty will likely

be sending out a call for nominations for the position soon. We also talked about exploring ways to increase funds (which seems to be a larger nationwide DEC subdivision discussion). One thing we discussed was a nominal fee for the webinars as fundraisers often result in most of the board members purchasing things and do not generate a ton of funds and don't really support the mission.
